TUITION DEPOSIT

A non-refundable and non-transferable Tuition Deposit of \$2,000 will be payable as outlined in the Letter of Offer (ELC, Prep[^], Year 5[^] and Year 7 only). For Prep, Year 5 and Year 7 entry, this deposit is only redeemable against tuition fees and credited to the April fee account in the year the student commences. Tuition Deposits paid with ELC entry become redeemable only against tuition fees when the student enters Prep and is credited to the April fee account of that Prep year.

[^] For Prep and Year 5 entry, the Tuition Deposit will apply from 2020 enrolments.

LATE FEES AND OVERDUE ACCOUNTS

Fees not paid by the payment due date noted on each statement and as listed in the School calendar, will incur a late fee of \$125*, which is not refundable or reversible. The School is not responsible for any delays in receiving your payment (including banking, postal delays or lost mail).

FAMILY DISCOUNT

Families with three or more children, in full-time 4 year old Kindergarten to Year 12 and concurrently attending the School, qualify for a 20% discount on tuition fees only for the third and/or youngest child and every child after the third.

WITHDRAWAL OF A STUDENT AFTER ENROLMENT

As per the conditions on the signed *Enrolment Agreement*, one term's notice in writing to the Head of School and the Registrar is required prior to the permanent withdrawal of a student. For the year-end leavers notice is required by the end of Term 3 holidays. If the required notice is not received a fee equivalent to one term's fees is payable.

CONSOLIDATED FEES

Consolidated Fees cover compulsory extras applicable to each Year Level, for example the student diary, camps/excursions, incursions, library and laboratory materials, ID cards and other required classroom materials. This fee does not cover books and stationery listed in the booklist, cost of the computer notebook or overseas trips. The annual fee is billed in the April account.
